Group Bookings, Deposits and Payment:

Thank you for booking your group tour with **Beyond the Vine**. A **non-refundable \$300 deposit** is now due to secure your date. You are considered the group contact for this reservation, as such, you will be responsible for collecting and providing **the outstanding balance 21 days prior to departure of your tour**. Coach rental, winery fees and food costs are based upon agreed numbers of _____ **guests**. Should your numbers not be reached then the group organizer or company shall be responsible for the remaining balance.

Cancellation Policy: 100% non-refundable if cancelled inside of 21 days. Payment: By Visa or MC only. **Please note: For tours that exceed 5 hours, an extra charge of \$50 per ½ hr.** will be applied to the group leader. **All tours booked after July 1st will be subject to the new HST.**

Condition of Touring:

Tours operate rain or shine, we reserve the right to alter, change or cancel the tour at any time. Unexpected circumstances may arise which could result in a change to departure points, modes of transportation, times, meals or itineraries. **Beyond the Vine** reserves the right to make such amendments and no refund is given unless the tour is cancelled by the operator. All tour guests are requested to report to the specified meeting point 15 minutes prior to the designated departure time. Scheduled tours will depart on time and cannot wait for delayed guests; in such circumstances no refund will be issued. **Beyond the Vine** reserves the right to cancel the tour if at any point the entire group or any member of the group appears to be inebriated or acts in an unsafe manner that may endanger themselves, other persons, or the operators providing such services. Guests will be disembarked and will have to find an alternative method of transportation with no refund. **Coolers with alcohol are not permitted onboard.** Guest's under the age of 19 years **cannot** participate on any **Beyond the Vine** tours. **Ontario's Alcohol Laws:** Arrive, Alive...With Ontario's liquor laws in effect, **Beyond the Vine** urges all tour guests to arrange to be picked up and to drive sober. **Beyond the Vine** can supply and arrange for taxi services for an additional cost.

Responsibility:

Beyond the Vine is not responsible for any falls, lost/stolen items, injury, and death or claims whatsoever arising from, connected with, or related to any activities engaged in by guests while on Tour. **Beyond the Vine** operates as an independent agent, supplying a guided service only and neither supervises nor controls the actions or suitability of services provided. All personal possessions are guest's responsibility at all times.
